## Russell Island 5K

It is hard to believe the Russell Island 5K is going to be holding the 9<sup>th</sup> annual run along with a pancake breakfast, September 3, 2022! Thanks to the support of our islanders, the RI5K and Pancake Breakfast, has made numerous donations to RIF, RIPOA, purchased dock benches, park benches, a ladder at the river access, and now a piece of playground equipment at the beach. Last year's funds paid for the material to replace the Russell Island sign, (thank you to Tony Ruggirello for his hard work repairing it), and we contributed \$310 to the RIYC, as matching funds, to Michele Preston's bingo shirt fundraiser.

The RI5K made a profit last year of \$3,709.09. RIF received \$1,335.00, RIPOA received \$320.00, RIYC received \$310.00, material for the sign \$471.07, and the remaining balance of \$1,273.02 is going towards the new playground equipment with a credit of \$79.92 being owed to RI5K from our upcoming 2022 run. Russell Islanders are very generous and supportive of the many fundraisers on our beautiful island. A big thank you to those who have helped the RI5K be successful by helping with set-up, race times, pancake flipping, running the bloody Mary bar, raffles, donations, etc. Also, thank you to all who have participated in our RI5K run and walk and Saturday breakfast for the past eight years!

## Kroger Community Rewards Program / AmazonSmile

### Kroger:

To get enrolled in the program, all you need to do is register online at [www.krogercommunityrewards.com](http://www.krogercommunityrewards.com) Be sure to have your Kroger Plus Card handy and register your card with the Russell Island Foundation after you sign up. If you do not yet have a Kroger Plus Card, they are available at the customer service desk at any Kroger store.

Here is a step-by-step explanation of what to do to get enrolled in this beneficial program:

1. Go to [www.krogercommunityrewards.com](http://www.krogercommunityrewards.com) and click on MICHIGAN, scroll down the page and click on the ENROLL box.
2. Click on SIGN UP TODAY in the “New Customer?” box.
3. Sign up for a Kroger Rewards Account by entering your zip code, clicking on favorite store, entering your email address and creating a password. You will need to agree to the terms and conditions.
4. You will then get a message to check in your email inbox and click on the link within the body of the email. Follow the instructions in your email.
5. Click on MY ACCOUNTY and use your email address and password to proceed to the next step.
6. Click on EDIT KROGER COMMUNITY REWARDS INFORMATION and input your Kroger Plus Card number. Update or confirm you information.
7. Find Russell Island Foundation which can be selected from the drop-down list (or enter the NPO number – 90286) click SELECT in the next section and Click SAVE CHANGES in the third section

To verify that you are enrolled correctly, you should see Russell Island Foundation on the bottom left portion of your information page. It will take 7-10 days before your purchases will begin earning rewards for the Russell Island Foundation after you have registered your Kroger Plus Card online. You will know that you have successfully registered your Kroger Plus Card because at the bottom of your Kroger receipt you will see: ***“At your request, Kroger is donating to The Russell Island Foundation”***.

REMEMBER that purchases will not count for the Russell Island Foundation until after you register your card – so please take the time to do that now! You will need to swipe your registered Kroger Plus Card or use the phone number that is related to your registered Kroger Plus Card when shopping for each purchase in order for it to count towards the quarterly rewards check sent to the Russell Island Foundation. For those of us who regularly shop at Kroger – this is an easy way to help the Foundation accrue monies.
